From the Archives

Colin Peardon gave us a copy of the newsletter from **August 2004!** Here are 2 items from it:

A Lawyer's Story

A lawyer purchased a box of very rare and expensive cigars, then insured them against, among other things, fire. Within a month, having smoked his entire stockpile of these great cigars and without yet having made even his first premium payment on the policy, the lawyer filed a claim against the insurance company. In his claim, the lawyer stated the cigars were lost 'in a series of small fires'. The insurance company refused to pay, citing the obvious reason, that the man had consumed the cigars in the normal fashion.

The lawyer sued – and WON! Delivering the ruling, the judge agreed with the insurance company that the claim was frivolous. If you click this link, please scroll down to the "Club Documents" section. In this section, you will find the documentation on how to use the 3 new laptops. You can also read the documentation for dealing cards or using the Bridge Timer/Clock software.

The new laptops contain all the files that were on the old laptops. Procedures for using the existing scoring program or existing teaching programs are unchanged.

One major difference between the old and new PC environment is that when you have finished

with the PC, **do not shut it down!** Just walk away and leave it turned on. The PCs backup their data to the other PCs overnight and to the "Cloud" (OneDrive).

Teacher's Corner

Opening Leads

With a strong sequence, lead the highest of the sequence. That tells partner you have at least the next one down, but not the one just above. King promises Queen, denies Ace, etc.

An extra detail is that when you are defending a suit contract you lead the top of two touching high cards, but against NT it's better to have a 3-card sequence or close to it. Examples:

AKx, KQ10, QJ9, J10x

Don't lead a 4th best when you have a strong sequence, partner will get confused!

Try It Out

Partner led the Queen against 3 NT. Declarer played 2 from Dummy, you followed (if you do high or low discouraging signals, you'd discourage). Declarer won with the King.

A couple of tricks later you're on lead. Seeing the Ace still there, should you play Spades or look for something else?

Answer

Persevere with the Partnership Suit! Don't be put off seeing the Ace still in Dummy, partner led a strong card, the Queen, because she has value in the suit, we expect at least Q J 10 or Q J 9. Your job is to help partner to flush out that Ace and make the rest of her suit good.

One of my early bridge mentors in WA was a lady who had played for years and years. She was a big believer in sticking to the partnership suit unless there's a cast-iron reason to change. It's still good advice, and this is a classic example. Just plug away at those Spades until partner's winners are set up.

Learning to play at QCBC

If you're a new player keen to learn and improve, here are some of the options.

Start with:

Beginner Classes: 8 lessons to get you started with Annette on Monday night or Christine on Wednesday mornings

Small Group Short Introductions: If you have a group of 4 (or have friends who would like to try this) let the club know and arrange for 4 lessons as a taster. This is enough to see if it's the game for you, and once you're hooked, you'll be able to join in the other groups and progress onward and upward.

Next step:

Help with Play, builds on the beginner course with different themes illustrated by set-up hands. Play the hands and talk through them with Richard Monday evening and Ian Wednesday morning

As you get more confident:

Supervised Play, play hands like a club session but you can still ask questions and take more time to think over the play. Ross, Claire, and various guest stars Wednesday mornings

When you feel ready:

Join in a club session. Monday (director Nick) and Wednesday (Peter) evenings are relaxed for newer players; Tuesday, Friday and Saturday

daytimes have a mix of levels. Tuesday evening and Thursday daytime are the stronger sessions, best to get some practice other days and work up to these.

Going further:

Improver Classes: more advanced themes with set hands with Richard and occasionally Andy Hung, look out for notices.

Mentor Nights: First Wednesday of the month, play through random hands with an advanced mentor watching and giving tips. If you enjoy your mentor's input, ask them for another game.

Restaurant Review

Michael and I decided to join Club Southside and check out the dining. We recommend booking a table for a weekend night. We went on Saturday at 5.30 pm and were lucky to get a table for two. The dining area is away from the noisier sections of the Club and is well decorated. It has several sections – one was closed off for a family birthday party. The menu is more extensive than we anticipated – offering good choices for vegetarians and meat lovers and quite a few vegan choices as well.

Although there was much on the menu that took our fancy, we were particularly impressed with the description of the Seafood Tower for Two People. "Crispy skinned baby barramundi with Asian dressing, 6 Oysters (2 natural, 2 Kilpatrick and 2 mornay), Half Shell Scallops with seaweed butter, Salt and Pepper Calamari, Garlic Prawns, Chunky Chips with thyme salt, Garlic Bread, and a generous serving of Fresh King Prawns and Smoked Salmon". All topped off with a complimentary bottle

of White Wine - for the very reasonable price of \$99.00.



The meal was fun to eat and thoroughly enjoyable. The Oysters, Scallops and Prawns were fresh and delicious. In truth we loved everything about the Seafood Tower. The only reasons we didn't eat the garlic bread was because we ran out of room in our stomachs. We heartily recommend a visit to the restaurant in Club Southside. Please allow 20-30 minutes for the chef to prepare this fabulous meal; it is well worth the wait.

You play randomly dealt boards and can ask questions throughout and to review each hand after you've played it. There is no scoring, no master points, no time pressure, and no shame.

You can ask for help with basic bidding and play techniques that may have slipped your mind since you did your lessons (months or years ago) and/or refine your bidding and play systems.

I coordinate the sessions and it is very helpful if you advise me in advance that you are attending so I can ensure we have a helpful number of mentors attending. Please contact me if you want to be added to the mailing list for this group.
