From The President



Some of the key activities of the Board recently are:

Grant application to improve the Wilton St carpark drainage and improve disability access

The maintenance committee has flown into action and developed a plan to address both the drainage and the disability access. It will cost approximately \$20,000. We have submitted 2 grant applications and will continue to apply for any appropriate grants that we can find. Unfortunately, we cannot commence the work until we win a grant. Meantime, I am pleased to advise that we have improved drainage in the carpark. It withstood the rigours of ex-cyclone Alfred very well.

Social activities for novice players

The membership and marketing committee is focusing initially on finding simple ways to enhance the QCBC experience for newer players. Many of our newer players are exploring options to find partners and to build friendships. We are trialling a social break in the Monday night session, including participants in beginners' classes and Help with Play. We are also holding welcome sessions for graduates of beginners' classes. We will run some initial activities and see how they go.

MyABF as a communication platform with members

The Board very recently decided to adopt MyABF as our primary communication platform, replacing

Pianola. This is early advice. You won't see any difference for a while because we must start by adding member information to the membership module. We believe that MyABF is an improved product because:

- We can collect some important information such as emergency contacts.
- We can add non-members people doing beginners lessons and Help with Play.
- We can focus our energy on one system instead of maintaining a couple of systems.
- We are all paying for it anyway because it is funded through our ABF dues.

Look out for a request to update your personal information so we can be confident that the information we keep about you is accurate.

Just a note that we will still use Pianola for session results for the present.

Administration and Governance

There seems to be a never-ending supply of administration and governance projects. We welcome enquiries but I won't bore you with full details. A few headlines:

- Work is continuing to update the Memorandum and Articles (Constitution). We are navigating some challenges and have had to seek legal advice about the best path forwards. We will present the updated M&A to you as soon as possible.
- The new accounting system, Xero, is now fully operational and providing the Board with good financial reports.
- We've just completed the 2025 membership dues process. We now have over 500 members.



Director's Corner



What to do About Revokes

We have all (for one reason or another) failed to follow suit when we could've and should've. In bridge this is called a "revoke". A revoke becomes established when the offending side plays to the trick after the revoke occurred. If the mistake is realised before this time, it is best to call the director to deal with the situation. If the mistake is by the defending side, there will be a major penalty card on the table and the director will inform the players as to how to proceed.

Sometimes it becomes apparent that someone has revoked later in the hand. If you have revoked, then you are under no obligation to draw attention to it (Law 9A5). If you realise that an opponent has revoked earlier in the hand, then you might draw attention to it straight away or wait until the end of the hand. The director cannot make any ruling until the end of the hand, so it is best to wait until the hand has been finished before calling him/her. Try to remember which trick the revoke occurred or at least the play on that trick. It is important that all players keep their cards in

order so that the play of the hand can be recreated if necessary.

Personally, I wait until the end of the hand to draw attention to a possible revoke. I find that the discussions surrounding whether the revoke has occurred to be an unwelcome and unnecessary distraction. If you do find yourself discussing a possible revoke in the middle of the hand, it is important to remember that you are not allowed to reveal any cards that have been quitted or get your opponent to reveal any quitted tricks. As always, it is forbidden to touch your opponent's cards. If there is dispute as to whether a revoke has occurred, then wait until the end of the hand and let the director sort it out.

Generally, there is a penalty of two tricks for winning the trick with the revoking card and then your side winning a subsequent trick, and a one trick penalty for not winning with the revoking card and then winning a subsequent trick. Note that often the trick adjustment only restores equity i.e. gives you the tricks you were going to win had the revoke not occurred. Non-offenders are often disappointed to find out that they aren't getting something extra because of the revoke. Sometimes these penalties are insufficient to restore equity, and the director needs to adjust further, e.g. in a no trump contract a player has revoked and thus prevented an opponent from running a suit. If you feel the revoke has caused this kind of damage, then explain to the director why a further adjustment is warranted. These situations can be quite complicated, and a playing director may want to reserve the ruling until the end of the session or at least until they have played their own hand.

One of the very few good things about playing online is that you can't revoke. As long as we are still playing bridge face to face, however, there will be revokes. So be careful you don't make too many and please be patient when an opponent makes one. Happy bridging.

Partnership Understandings

Opponents are entitled to know everything you know about your partnership understandings. Here are four extracts from the QBA/ABF Alerting Regulations:

- It is an essential principle of the game of bridge that players may not have secret agreements with their partners, either in bidding or in card play. All agreements must be fully available and fully disclosed to the opponents.
- The principle is to disclose, not as little as you must, but as much as you can, and as comprehensibly as you can. A careless failure to follow this policy may result in an adjusted score, and possibly procedural penalties, where opponents have been damaged. If a player makes a positive effort to meet their obligations under full disclosure, they will rarely if ever fall foul of these regulations.
- If an enquiry is made, a full explanation of the call must be given. This includes any conventional or partnership agreement, whether the agreement is explicit or based on partnership experience. Explanations may well include distributions and point ranges specifically excluded by a call, as well as those shown directly. When giving explanations, it is not necessary to repeat information given earlier in the hand, unless such information is requested. When explaining an alerted or selfalerting call, players should indicate if this same call might have a slightly different meaning (e.g. different point range) due to a variation of vulnerabilities and/or position around the table.
- If there is no partnership agreement as to the meaning of a call, the player must say so (by saying, "Undiscussed", for example), and not attempt to offer a possible explanation. When, however, as a result of partnership experience and style, one is able to form a coherent view of the likely meaning of an undiscussed call, that information shall be given to the opponents. Where a call is undiscussed, the player should not offer statements such as "I take it to mean..." or "I'm treating it as...". Such a response is improper as it provides unauthorised information to partner.

Perhaps your partner likes to *deliberately* describe a hand that has no resemblance to the one he holds. Funny the first time, unless doubled and down six. The sequence is recorded in the Psyche Register. I am not talking about accidental mis-bids,

forgetting the system or beginners making mistakes.

For example, suppose you think that your partner may be **seriously mis-describing** their hand. If it crosses your mind that partner is up to his old tricks again, then you have an awareness. So, unless divulged to the opponents, you have a secret partnership understanding and that is hot water you do not wish to be in.

Being a Good Partner

- Do not give lessons, unless you are being paid to do so. "According to an evening paper, there are only five real authorities on Bridge in this country. Odd how often one gets one of them as a partner. " (Punch).
- Let your partner know that you like them.
- Never say anything to your partner unless you would want him to say the same to you.
- Remember you and your partner are on the same side.
- Do not forget that your partner wants to win as much as you do.
- If you feel the urge to be nasty, sarcastic, critical or loud, excuse yourself and take a walk.
- When there is time between hands, do not discuss Bridge.
- Never, ever criticize or embarrass your partner in front of others.
- Bridge is for fun; it is not to show how smart you are or how dumb someone else is.
- Trust your partner; do not assume s/he has made a mistake.
- Although it may be unfashionable, it really is okay to be pleasant to a partner with whom you also happen to live.
- Think twice before verbally analysing a hand. Do not embarrass yourself with a hasty, inaccurate comment. Remember: "The worst analysts and the biggest talkers are often one and the same." (Bridge columnist Frank Stewart).
